- The results of this Placement Test (Password English test) could only be recognized or accepted by Scots English College (SCOTS) and other educational institutions with whom SCOTS has pathway agreements.
- The Placement test fee is non-refundable irrespective of the outcome of the candidate's attempt. The fee could however be waived or deducted upon enrolment at SCOTS or educational institutions with whom SCOTS has pathway agreements.
- Candidates wishing to cancel their test booking must notify Student Services directly or via their agent at least 24 hours prior to the test. Failure to do so may lead to charges. Late cancelations will incur a fee of AU\$24 (inc. GST) or 30% of the Placement Test's fee. No charges will apply to test deferments.
- It is the candidate's responsibility to read and understand all information and instructions related to the placement test as well as to ensure the technical requirements are met. SCOTS bears no responsibility for technical errors encountered or experienced by the candidate. Candidates requesting a second attempt based on claims regarding the impact of technical difficulties on the outcome of the first attempt will be required to book a new placement test and pay another fee of AU\$80 (inc. GST).
- Candidates wishing to dispute the score of their placement test may do so in writing and send their appeal by email to:
